- (v) liaising with client Ministries/Departments on matters relating to design briefs and expenditure;
- (vi) managing and coordinating field surveys and user reaction investigations;

- (vii) analyzing data from field surveys and establishment of space standards and better architectural detailing;
- (viii) monitoring and evaluating sketch/scheme designs done by consultants for necessary recommendations for approval; and
- (ix) evaluating consultants fees and making recommendations for payment; and
- (x) assessing training needs in the Units.

As County works officer, the officer will be in charge of all Architectural, Engineering and Quantity Surveying services in the County. Specific details and responsibilities will include;

- (i) design and supervision of construction and maintenance of public buildings, civil and other public works;
- (ii) research activities; and
- (iii) administration and supervision of all staff working under him/her.

- (ii) repair and maintenance of electrical/electronic installations in government institutions;
- (iii) checking and recommending for approval of engineering consultants' designs;
- (iv) evaluation, certifying and recommending fees submitted by consultants;
- (v) co-ordination of improvements of electrical and electronic services; and

(vi) rural electrification programmes and lightning protection of government installations.

As a County Works Officer, he/she will be in charge of all Architectural, Engineering and Quantity Surveying services in the county. Duties and responsibilities at this level will include:-

- (i) coordinating design, supervision of construction and maintenance of public buildings, civil and other public works;
- (ii) research activities; and
- (iii) administration and supervision of all staff working under him/her.

An officer at this level may be deployed as a head of a unit at Headquarters or as a County Works Officer or a Regional Structural Engineer. The duties and responsibilities at the Headquarters and Provincial level will include work in the specialized fields of engineering in one of the following:

1. Building and Allied Structures

Duties and responsibilities include:

- (i) design, detailing and site supervision of structures in various materials and forms of construction;
- (ii) liaison with Architects, local authorities and other Ministries on project development;

- (iii) checking and monitoring projects designed by consulting engineers; and
- (iv) direction and control of engineers and Structural Assistants working in the specific project.

2. Marine

Duties and responsibilities include:

- (i) assessment of the site, location, planning, design, detailing, preparation of bill of quantities and contract documents;
- (ii) supervision and administration of bridges and allied structures for national roads and similar structures pertaining to development undertaken by other Ministries;
- (iii) design, detailing, preparation of bill of quantities and contract documents for jetties, seawalls, docking and berthing facilities and supervision of the structures;
- (iv) checking and monitoring projects designed by consulting engineers; and
- (v) direction and control of junior engineers and structural assistants working on specific projects.

3. Civil

Duties and responsibilities include:

- (i) design, detailing, site supervision and maintenance of the sewerage drainage, roads and paved areas pertaining to public buildings; and
- (ii) checking and monitoring projects designed by consultants.

4. Construction

Duties and responsibilities include:

- (i) supervision of structural, civil and marine works prepared by the Department and consulting engineers;
- (ii) enforcement of specifications, compliance with engineers' drawings, conditions of contract, quality control, approval and measurement of completed works, progress reports and guidance of Regional/ County structural engineers on all technical aspects of the work.

5. Research

Duties and responsibilities include:

- (i) supervision and control of applied research projects pertaining to structural materials, foundations, structural elements, constructional techniques, marine and building technology.
- (ii) undertaking work programmes in all the functional areas; and
- (iii) training and development of staff under him/her.

6. County Works Officer

Duties and responsibilities include:

- (i) being in charge of all Architectural, Engineering and Quantity Surveying services in the District;
- (ii) coordination of design, supervision of construction and maintenance of public buildings, civil and other public works;

- (iii) undertaking research activities; and
- (iv) administration and supervision of all staff working under him/her.

ARCHITECT I - TWENTY NINE (29) POSTS - V/NO. 30/2023

Basic Salary Scale: Kshs.42,970 - Kshs. 59,120 p.m. - (CSG 9)

Requirements for Appointment

Duties and Responsibilities

(ii) repair and maintenance of electrical/electronic installations in airports, waterworks, offices, workshops, conference complexes and other government facilities.

- (i) design of mechanical services in government buildings and construction works;
- (ii) repair, and maintenance of mechanical installations in airports, waterworks, offices, workshops conference complexes and other government facilities.
